CHILD CARE DESERTS

A child care desert is defined as a community or neighborhood where there are either no licensed child care providers, or where there are more than three children for every available slot.


Impact on Iowa Women

Because of a lack of child care options, many parents are pushed out of the workforce to care for their children.

Because of a lack of nearby options, parents must travel further out of their way to seek child care, sometimes limiting the time they have at work, hurting hourly workers.

Due to the extreme shortage of care, providers recommend parents begin looking for child care openings before their child is even born!

THE CLIFF EFFECT

Occurs when a parent receiving a child care subsidy no longer meets the eligibility requirements—often due to a small wage increase—triggering the complete loss of financial assistance after completing 12 months on the CCA Plus Program. An hourly wage increase of as little as 15 cents can push a parent over the eligibility threshold. In common cases like these, the raise is not substantial enough to offset the thousands of dollars in lost benefits, leaving the parent worse off financially.

From 2012⁵ to 2017⁴, the average cost of child care for an infant in a registered home in Iowa increased 5 percent, while the cost of care for an infant in a licensed child care center rose 11 percent. In that time, the median wage rose only 4 percent and 10 percent for a married couple. ³

THE WORKFORCE GAP


Occurs when new parents (particularly mothers) are discouraged from participating in the workforce, often due to the high costs of child care, a lack of child care options, or a lack of on-the-job flexibility.

Impact on Iowa Women

Women who temporarily exit the workforce to take care of a child often miss opportunities to gain skills and connections that allow them to advance in their careers, putting them at a disadvantage upon their return.

This also limits income, often in the peak of their earning years, putting them at a financial disadvantage when it's time to retire.

CHILD CARE SOLUTIONS FUND

While there are several organizations committed to helping solve lowa's child care crisis—many struggle to secure the financial support they need.

Funds from this initiative will be invested in organizations and institutions that focus on strategies to increase women's economic security by decreasing the work force gap through access to quality, affordable child care.

Child Care Solutions Fund Grantees (to date)

2018: Linking Families & Communities – Grant funds were used to contract with an architect to complete pre-design work for an expansion of Community Early Childhood Center, as well as a new center to meet the growing demand for child care in the Fort Dodge area. 2019: Ready Set Grow (RSG)—Grant funds will help RSG open a new facility in a former retirement center in Storm Lake, Iowa in the spring of 2019, expanding child care options for parents in Buena Vista County.

Davis County Daycare and Preschool (DCDP)—Funds will allow DCDP to upgrade its programming and age-appropriate learning tools, as well as to open an additional classroom for 24 four year olds.

BUILDING COMMUNITY CHILD CARE SOLUTIONS TOUR

Building Community Child Care Solutions is a state-wide initiative led by IWF that was created to explore the tactics and strategies that can help communities tackle a range of child care-related issues.
