Our Work

IWF takes two complementary approaches to improve women's economic stability:

The Upstream Approach

Focusing on the root causes of barriers for women and aims to prevent them from occurring in the first place

The Downstream Approach

Providing direct support to alleviate the impacts of systemic challenges on organizations and those they serve

IWF applies both approaches through:

Research, Education, Collaboration, Advocacy, Grantmaking

Annual Grant Programs

Emergency Grants

Up to \$1,000 awarded to cover unexpected and unbudgeted expenses that make it difficult or impossible to serve clients

Cycle currently open

Core Grants

Up to \$50,000 awarded to initiatives that tackle at least one of the six barriers to women's economic self-sufficiency

Cycle opens April 28

IWF no longer has a separate process for childcare grants. Only one application required!



Core Grants

What We Fund

- 501(c)3 organizations or licensed childcare facilities
 - Registered in-home providers included
- Serving women and/or girls in Iowa
 - Don't need to exclusively serve women or girls
- Tackling at least one of the six barriers
- Up to \$50,000 may be requested

What We Don't Fund

- Capital campaigns
- Reimbursement for previously incurred expenses
 - Funds are to be used between October 1, 2025 and September 30, 2026
- Political candidate campaigns
- Promotion of religious activities

Grant Priorities

Housing

IWF funds initiatives that assist women and children experiencing homelessness or housing insecurity

Examples: emergency shelters, transitional housing, life-skills programs to maintain stable housing

Transportation

IWF funds initiatives that help women obtain safe and quality means of transportation

Examples: assistance finding and securing a vehicle, financial-lending and credit-building education, vehicle maintenance skill-building, registration and title fee assistance

Grant Priorities

Education & Training

IWF funds initiatives that prepare women or girls to enter the workforce or advance within their field

Examples: job-specific training, apprenticeship programs, financial literacy education, employment readiness programs

Employment

IWF funds initiatives that support women in seeking or maintaining employment

Examples: resume-writing and job-application assistance, employment retention curriculum, career advancement programs

Grant Priorities

Childcare

IWF funds initiatives that increase access to quality and affordable childcare

Examples: center expansion, furniture and equipment purchasing, curricula purchasing, provider training, before/after-school programs, increasing options for second/third-shift workers

Mentorship

IWF funds initiatives that encourage women to share their talents to inspire new female leaders

Examples: professional networking programs, career exploration programs, role model pairing programs, leadership skills and self-esteem building programs

Funding Timeline

April	April 28: Letters of Interest OPEN
May	May 16: Letters of Interest DUE
June	Second week of June: Eligible applicants invited to complete a full application
July	July 11: Full Applications DUE
August	Awardees selected after review process; Applicants notified of their status
September	Funds dispersed to awardees
October	Awardees celebrated at Luncheon; Expenditure cycle begins (through Sept 2026)

Review Process

A multi-layered process is used for selecting grant recipient organizations

- 1. Eligibility Screening Letters of Interest
- 2. Community Volunteer Review Full Applications
- 3. IWF Grants Committee Review Full Applications
- 4. IWF Board of Directors Approval August Board Meeting

Key Things to Remember

- ★ Must serve women or girls in Iowa
- ★ Must address at least one of the six barriers
- ★ Letters of Interest due **May 16**
